Clinical, diagnostic, teaching, research, or production facilities are one of many field that utilize BSL's for their research.


Why build a BSL LAB?

These specialized containment facilities are used when indigenous or exotic agents are present and may cause serious or potentially lethal disease as a result of inhalation exposure.

What is BSL 1- 4 Classification?

- BSL-1 is a standard containment Facility with limited access. This type of facility contains no disease causing agents and minimum of hazards.
- ♦ BSL-2 introduces moderately hazardous pathogenic agents into the facility. Sharp agents and potentially hazardous aerosols can be present in this type of facility.
- ♦ **BSL-3** introduces working with exotic agents known to cause serious or potentially lethal illness.
- ♦ **BSL-4** introduces dangerous and exotic agents posing serious and life threatening illness.






